Minutes: The minutes of the Annual General Meeting held on May 12th, 2009 were available in the agenda papers. These were accepted on the motion of Alan Sutherland and Laurie Fagan.

**Business:**

**Item 1: Re-development of Rose Green**

Lloyd gave a brief outline of the project, thanking in particular Ken Allen and Mike Loughhead for their work in the formative stages of the new club.

The completion date is set for November 15<sup>th</sup>, with the handover to the Club by Council set for November 17<sup>th</sup>. A temporary timber handrail will be in place until the permanent one is manufactured. The marine carpet on the surrounds of the green can't be laid until the concrete has completely dried out.

After November 17<sup>th</sup>, the Rose Green will be available for play by members under the control of the Greens Director, Ray Phillips. The new bar will be open for use under the control of Bar Director, Glenn Edwards. The plaza area will be under the control of the House Committee, with Bob Smith as Chairman.

Lloyd also thanked the members of the sub-committee who have been liaising with members and the Council for the duration of the project, viz; Bob Smith, Noel Dobson, Jim Shanahan and Steve Mitchell.

An official opening ceremony is planned for Sunday 6<sup>th</sup> February in conjunction with our Memorial Day tournament.

In response to questions, Lloyd reported that a committee is looking into upgrading the security arrangements on the Rose Green, and indeed over the whole complex. Ray Phillips presented a paper outlining issues to be considering preserving the playing surface. There was much discussion around dumping and the use of dump mats. This issue will be considered further.

## **Item 2: Uniforms**

John Davy outlined the procedure for reaching a decision at the meeting. He also gave a brief history of the current shirt, and the brief presented when the club was formed as to the design.

Don Dickinson then presented the proposal for a new design, including sponsorships gained and the costs of a new shirt. He presented three new possible designs.

Questions asked centered around the club jacket, the amount of maroon in the proposed designs and the current stock of shirts.

A vote of members was taken, with Pam McGurgan, Laurie Fagan and Graeme Betts acting as scrutineers. The results were:

The motion to change the design of the club shirts was lost because both groups did not vote in favour.

# Board of Management Reports

## **Chairman**

Our Presidents were ably supported by strong groups of officials who provided the members with an amazing range of events. My congratulations go to Presidents Pam and Laurie and their teams for an outstanding season that saw our Club in the forefront of bowls in the Goulburn Valley Association.

Our Division 1 Ladies again set the pace with another pennant win after a hard fought series. All our Ladies teams performed very well with Division 2 making the finals, Division 3 being runner up and the other teams being very competitive. In the Men's section we enjoyed success in Division 3 winning a third consecutive Pennant in that division. Division 1 had an outstanding season finishing minor premiers and just losing out in the preliminary final to Kyabram who were the eventual premiers. Our Divisions 2 and 5 made the finals and our Division 4 teams were competitive throughout the season.

I would like to acknowledge the hard work of Margo Dobson, Betty Bicknell and Wally Bramley in organising our feature tournaments. Theirs is a difficult job in attracting bowlers to our tournaments as there are so many options available to bowlers nowadays. However our Committee was up to the challenge and delivered us many excellent tournaments. Thank you for a job really well done.

Our Indoor Bowls Section enjoyed another successful season and provided our members with the opportunity to play sport throughout the winter months. Thanks to President Fred Murley and Secretary Keith Dudley for their work controlling this section of our Club.

This season our Club has had a new green's director in Ray Phillips, who had the difficult task of juggling the play on only two greens for the first half of the season and to cohabit the site with the builders who were constructing the under cover green. Ray managed this task very well with our greens bowling extremely well. This was highlighted by the GVBA's choice of our greens to host many of their events. Thank you Ray and your marvellous team of workers for an outstanding job.

Our Bar was again controlled by Glen Edwards. This is a big job well done by Glen. There is a lot of time and effort required to make the bar run profitably and efficiently, but Glen has delivered the goods again. The profit from the bar makes a significant contribution to the Club's operating profits. Many thanks Glen and your team of helpers.

We all enjoyed the Social events staged by our Social Committee. The *Jazz on the Greens* was again a highlight but I am sure our members and their guests also appreciated the monthly *Chicken and Salad* Nights. Thank you to the Social Director Ken Allen and his loyal team for a really great season of entertainment.

Sponsorship plays an important part in our Club's Finances. This season our Sponsorship Director, Alan Sutherland, delivered a record result with over \$18,000.00 in sponsorship. This was an outstanding result and I thank you Alan for your great work.

For our members, I ask you to note the businesses that provide Sponsorship to our Club and whenever the opportunity presents itself, please support these businesses.

This season our Club's Ladies have done us proud with their outstanding work in the kitchen, presenting afternoon teas of the highest standard and catering for many special events throughout the season. Many thanks to Margaret Davy and her wonderful team of helpers.

Our Club House has been kept in tip top condition by the dedicated work of Bob Smith. I thank you Bob for your outstanding work in this area. Also I would like to compliment our Club House Cleaners Flo Holland and Kath Murley for their expert help for keeping our Club House in top condition. Thank you Ladies.

The season had many highlights but the outstanding occasion was undoubtedly the opening of the Undercover Rose Green and Plaza. At the opening in February we were pleased to welcome to our Club officials from Bowls Australia, Bowls Victoria, Goulburn Valley Associations, our Local MLA Jeanette Powell, Council Officials and the Mayor Geoff Dobson who officially opened the Complex.

I would like to express my appreciation for the advice and assistance provided by the building sub-committee, Bob Smith, Noel Dobson, Jim Shanahan and Steve Mitchell who attended to many critical matters during the design and construction period. I especially want to thank Bob Smith for the dedicated work he has put in as our Club's Liaison Officer working with the Council and the Builders during the Construction period. I am sure the finish on the project would not have been as successful as it is without Bob's daily visits.

Our other highlights included acting as the principal host Club for the Ladies Country Carnival, hosting of the State 4's and numerous Goulburn Valley and Murray Association Events.

Our financial position is very strong. We have paid for much of the improvements on our new development. However we have borrowed \$39,000 from the Bendigo Bank to pay for the major

items of expenditure associated with the fit out of the Rose Green. This loan is to be repaid over five years.

Our trading surplus for the Season was \$27,000 with cash reserves in our Bank Accounts \$126,000.

We have opened a special Bank Account to hold funds for the future replacement of the carpet on the Rose Green. This season we have paid \$10,000 into this Account.

I would like to acknowledge work carried out by the Board Secretary Jim Shanahan, who has again provided us with first class secretarial services. Jim has also had a significant work load in considering the implications of unification on our Clubs Rules and Constitution. Jim has also created an outstanding Web Site for our Club. Thank you Jim for all your valued assistance.

I must also acknowledge the dedicated work of our Treasurer Glenice Mawson. Glenice has diligently carried out her role and the financial success of our Club is in no small way due to her work.

Looking ahead I can see some difficult issues to deal with in regards to unification and in particular the conduct of Tuesday and Saturday Pennant Competition. Our Club will also have to consider alterations to our Rules and Constitution to allow unification to operate as intended. We may also have to reconstruct our administration and the role and size of the Board.

Our major events committee have been negotiating with Bowls Victoria for the rights to conduct a major event at Shepparton Park commencing next season. At this stage I am not permitted to disclose any more details except to say that an official announcement will be made by all parties in the middle of May.

I strongly recommend we don't allow the Club to extend to the point that we can no longer effectively administer the Club with volunteer officials. I have observed several sporting clubs that have outgrown their club's management skills, having engaged a manager and then run into financial ruin.

The Board decided not to proceed at this stage with the construction of the fourth green but will install marker posts to define our control of this land and will use the land as an extension of the western car park.

Security of our premises is a major concern of the Board and to this end the Board has entered into negotiations with the Council with a view of installing a security fence around the unprotected areas of the Club's land.

Finally, as I will not be offering myself for re-election as Chairman, I would like to take this opportunity to thank all the members for their support and encouragement throughout the last five years.

I would especially like to thank those members who served on the Board with me over this period. We have achieved much as a team and I have enjoyed dealing with the challenges that were presented to the Club.

I wish the incoming Chairman and the Board every success for the season ahead and thank you one and all for the honour of being your Club's Club Chairman for five seasons.

## **Club Secretary**

The past year should have been a quiet year, with no Australian Open to be held here and no major events planned. However this was not the case and we were all extremely busy as the club grew in size and stature amongst the wider bowls community. The Board has met on a regular basis and has dealt with a wide range of issues. Discussion and debate was often quite robust with all members contributing, but the motivating factor for all members was the long term interests of the Club.

The highlight of the year was most certainly the handover and official opening of the undercover Rose Green, which finalised the Memorandum of Understanding with the Council. When you look at the former Shepparton Bowling Club site at the lake and look at what we have here, there can be no doubt that both clubs took the right decision in accepting the Council's offer to merge. We should be extremely pleased and proud of our facilities. Many visitors wanted to take the venue back home with them, and we have already had clubs asking for details of plans, costs, etc as they think about copying it. The Board authorised a good deal of Club funds for items over and above the contract so that the finished produce was something we could all be proud of.

Even though there was no Australian Open, we did host quite a number of events that had a State wide or region wide focus. The availability of the undercover green certainly made many of these possible, and enhanced our standing as a venue for such events. There was universal high praise for our venue and the hospitality provided by our members. As Lloyd has alluded, there is news

coming regarding a major event to be announced soon.

Of course none of these facilities and events happen by themselves, they take a lot of planning and preparation by many people. This I feel is the greatest strength of our club. There are always members willing to put their hand up when a call is put out for helpers, and in fact many members just get in and do things to help and improve the club without being asked. This creates the feeling of "Our Club" rather than "The Club." I hope this continues and we continue to be a basically volunteer club, as when there are paid employees to do everything, members lose the feeling of ownership. We welcomed fifteen new full members, twenty two social members and one junior member during the year, and at the end of the year there are 199 full members and 33 social members in the club.

Our Club has had a good year both on and off the greens and mats. Details of the successes on the greens are provided elsewhere in this report, and our Treasurer, Glenice, has provided details of our financial status. These make good reading and show that we are in a sound position on all fronts.

During the year we were able to become involved in the *Broadband For Seniors* program, a federal government initiative. This program provided the club with two computers, furniture and broadband access so that we could provide internet access, training and support to our members. Bill Chilcott, Ron Holland and myself have been providing this training, but it must be said that Bill has done the lion's share and for this Ron and I are most grateful. Reports from participants have been very good. Our contract to provide this service ends in June, but we will continue to provide the service while there is a need.

It has been very pleasing to receive positive feedback and suggestions regarding our club website. Thanks must go to the selection committees for their diligence in uploading their teams each week. If members wish to see additional content on the site I would be pleased to hear their ideas.
