1. Full time students over the age of 18 years pay only \$20 club membership, while retaining the entitlements of full membership.
 2. **Social bowling membership** allows use of club greens, a gate key will be provided. Does not include bringing other bowlers / guests to the club.

What happens to this application

1. You should submit it to the Club Secretary.
2. The Club Secretary places it on the notice board for at least seven days prior to the next Board meeting.
3. The application is tabled at the Board meeting for consideration.
4. A vote is taken, and a decision made according to Clause 5 of the Constitution.
5. If the application is rejected, the Club Secretary will write to inform you and those who nominated you, and advise that no further application can be made for a period of six months from the date of the Board meeting.
6. If your application is successful, the Club Secretary writes to you to let you know. The letter will include the fees payable, and a request that you obtain a transfer from the previous Club at your own expense (if applicable). It will also advise that affiliation cannot take place until such time as appropriate fees are paid and transfer (if applicable) arranged.
7. You must pay the fees within 28 days or the application will lapse.
8. The Section President and the members who nominated you are notified that your application has been successful, and that they should ensure the you are made welcome, and aware of Club policies and practices.
9. The Club Treasurer will inform the Club Secretary when fees have been paid.
10. Your name will be included on the register of members as required under Clause 13 (1) of the Constitution.
11. The Club Secretary will then photocopy the application form and pass this onto the Secretary of the appropriate Bowls Section.
12. The Section Secretary will check with you as to the status of the transfer (if applicable).
13. The Section Secretary will arrange your affiliation with the appropriate body and advise the Selectors of your availability.
