## **Reports from Board Directors and Section Presidents**

#### Chairman - Stan Hester

In presenting this report for season 2014-2105 I can say that this year has been a very successful one both on and off the greens.

Whilst our membership remains static we need to continue to seek new members to cover the losses due to members ageing and/or leaving the Club to bowl elsewhere. Membership in Bowls Clubs everywhere is dropping and we must do what we can to alleviate this decline in those persons who are participating in our sport. Each of us must do what we can to attract people to join our Club and to take up the sport of lawn bowls.

Financially the year has been in line with last year and we are pleased to say that again we have been able to hold most of our sponsors and to attract some new ones. However, sponsorship within the bowls fraternity is getting harder to maintain due to the current difficult trading conditions prevailing at the moment. We are fortunate that we were able to again hold the Victoria Open in 2014 which returned a significant financial benefit to the Club. We have been advised that we will again host the 2015 Victorian Open.

The Board successfully obtained Grants to assist with the purchase and installation of Blinds at the southern end of the Rose Green and new shades at the northern end of the Foundation Green. In addition some bench seats and table/chair settings were also purchased. Some additional equipment for use on the greens was purchased to assist in the work of the Green's Director.

The bowling activity of the Club had its best year for many seasons with the Mid Week Pennant winning two premierships and one runner-up. The Saturday Pennant achieved a similar result with two premierships and one runner-up. Both sections won their respective Division 1 premiership. Again we must thank our Coach, Mark Ryan, for his contribution to the success that we achieved. We must congratulate the Selectors, both Mid-Week and Saturday, for their efforts in managing the selection of teams and giving all members the opportunity to participate and finding players when shortages occurred.

Congratulations to our 2015 Club Champions, Marika Armstrong and Vince Page.

The Victorian Open Bowls Tournament was conducted in November and I would like to thank the Committee that set this event in place, originally with Alan Sutherland as Chairperson. However due to his illness he was unable to carry out this role. Fortunately Jeff Boyle stepped in and with the support of Bill Chilcott, as Secretary, and the Committee they did a magnificent job. This team of people worked alongside Bowls Victoria and the Greater Shepparton Council to again bring the Victorian Open to the Goulburn Valley of which some 16 Clubs being used throughout the tournament.

The Board's thanks go to the 100 odd members who volunteered in some way to make the event so successful. The work done by the volunteers covered long hours over the seven days and included work on the greens, setting-up, catering, record keeping and eventually the final clean-up. The Board really appreciates the efforts of all of the volunteers.

The annual Charity Day was again very successful with a full house of entries and bundles of prizes to be won. The efforts of the Committee must be congratulated, along with those members who assisted in various ways. At the end of the day an amount of \$5,181 was raised and passed on to Shepparton Villages to assist with their development work in the community.

The Winter Committee are to be congratulated for their efforts in arranging bowls events for our members and visitors. Again the Board expresses its thanks to the Committee.

The Catering Committee consisting of Barb Allen and her team of ladies have again done a magnificent job in catering, not only for normal events, but many of the special events that were held at the Club. Particular mention must be made of the efforts put in during the Victorian Open. The Board has accepted the resignation of Barb Allen as Catering Manager and wishes to place on record the wonderful work that she has done over the past number of years. We thank her and wish her well in the future.

Alan Doble, our Booking Officer, has had another busy year with many corporate days, barefoot bowling days/nights and other events that he has secured for the Club. These events bring much needed funds and hopefully new members. Our thanks also go to those members who assisted Alan with his duties. Alan has advised the Board that he will not be seeking re-appointment and the Board expresses its thanks for the years of work he has given the Club in his role.

Our Sponsorship Manager, Murray Phillips, has spent a lot of time in endeavouring to retain all of our sponsors and obtaining some new sponsors. This has again been a difficult task due to the current financial conditions. Our thanks go to Murray for his work during the year. Murray will be relinquishing this role and we will be seeking a member to replace him.

Our Social Committee failed to be created at the last Annual Meeting but thanks to Wes and Val Gibbs who took over and with the help of some members continued the work of the Social Committee. The Chicken and Salad nights were enjoyed by many members whilst the Friday night Happy Hour was also a feature. Thanks go to Robyn McFadyen for her contribution towards the Friday Night social events.

The greens are maintained by a band of regular volunteers who work tirelessly to see that the greens are always up to the high standard that our Greens Director, Ray Phillips expects. This year the volunteers consisted of Murray Phillips, Bruce Tully, Graeme Sinclair, John McKenzie, Lynton Burkett, Bill Probst, Glen Edwards, Brian Hardy, Reg Jeffries, Graham Cross, Rob Thorne and Ron Holland. To all of these men we say thank you.

Over 60's were organised by Jim Broadbent and his Committee and the season was again well enjoyed. Night Pennant was again a highlight for the summer months and our thanks go to Jim Broadbent and his Committee. This event is very popular and is well attended by members and visitors.

The popular Thursday 2 x 2's are a special event that attracts a large number of members and visitors who really appreciate the format. Our thanks go to the Committee that conducts this event.

The Ladies Section is to be congratulated on their decision to commence a Ladies Social competition similar to the Thursday 2 x 2's, and a 60 and Over competition. These events are growing slowly but I am sure that they will grow and become successful events. Our thanks go to the organisers and members who are supporting the events.

This year our Tournament Secretaries, Di Hands and Wes Gibbs, together with their assistants ran the usual tournaments but they feel that these were not as well attended as in the past.

The Board expresses its thanks to our Bowls Section Presidents and their Committees for the work put in to see that the bowling activities of the Club continue to provide members with a range of events that enable members to enjoy the facilities of the Club. To my Deputy Chairman, Wes Gibbs, I say thank you for all of the work you have overseen and done to maintain the facilities of the Club. Also my personal thanks to Wes who stepped in and assumed the role of Chairman during my recent illness, thanks Wes.

To our Board Secretary/Treasurer, Jim Shanahan, we say thanks for your efforts to maintain the dual roles and to keep the Board up to date on their affairs of the Club.

We look forward to another year of success both on and off the greens.

#### Deputy Chairman - Wes Gibbs

It is pleasing to report that many improvements have been made to the Clubhouse and the surroundings.

New roll-up blinds have been installed on the southern side and south-east corner of the Rose Green. These blinds will only be operated by members appointed by the Board.

New floor coverings have been laid in the Clubhouse at Council's expense. We hope that this will improve bowling for the Indoor bowlers.

Shelving has been installed in the Bar fridge. This enables quicker reloading and easier serving. A number of aluminum seats have been purchased for around the Greens. New shade cloth has been installed and more will be fitted to many areas of the facilities in the future.

Grants through the Greater Shepparton City Council have enabled us to proceed with many of these projects.

The entrance gate locks have been altered so as the gates are automatically locked from the outside when closed.

Many small running repairs have been carried out on the Clubhouse and surroundings.

I would sincerely like to thank all the members who have assisted me in any of these tasks.

#### Secretary - Jim Shanahan

It is with pleasure that I report to this meeting on the activities of the Board. The past club year has been a very busy one with many and varied issues discussed at the Board table. The focus of the Board is centred around membership, facilities and finances, and all of these aspects were fully covered this year. It was disappointing that Alan Sutherland had to withdraw due to health issues, but his place was filled by Glenn Edwards who represented the Men's Section well.

The Board met on eighteen occasions during the year. All meetings were well attended and all discussions conducted in an extremely harmonious atmosphere. Topics discussed ranged across many areas, including; specific member concerns, facility maintenance, improvement and development, cleaning, future planning, member comfort and safety, coaching, financial decisions, alterations to Regulations, banking arrangements, liaison with the Kialla Sports and Community Centre and City Council, recycling, security, internet access, equipment purchases, grant applications and Section and Bowls Committee concerns, to list just a few.

The year has been another good one with our members again displaying a willingness to pitch in and help with major events. The Victorian Open was again a great success, with many members helping out. Throughout the year members regularly help out with the barbecue, bar, greens, surrounds, visiting groups, etc and this all helps promote our club as well as foster a sense of ownership of the club.

We were successful with grant applications this year and the new blinds on the Rose Green and shades on the Foundation Green were part funded by the City Council. We will also be purchasing a *bain marie* thanks to another Council grant.

A shade sail is to erected over the concrete area at the north end of the clubhouse during the Winter break. We are waiting to hear whether this will be funded by a grant. The shade runners between the Foundation and Rose Greens are currently being replaced.

Members have been kept informed of issues through monthly newsletters, weekly Shepp News reports (well done Jeff Boyle), reports at Friday's *Happy Hour* and an information session conducted in December. Members are encouraged make the most of these and to seek further clarification if required. Member feedback has been sought via the recent club survey. The results of this survey are being analysed and will form part of our future planning process.

You will have noticed that the Board has declared the club a Smoke Free Premises. This was done in the interests of members health. Smoking is not permitted within the club boundary.

Finally I would like to thank all members who have helped the Club in any way, and in particular those who have assisted me in any way.

#### **Greens Director - Ray Phillips**

We have come to the end of a very successful season and what a season it has been with both Midweek and Saturday teams playing in finals.

Both grass greens have had a lot of play on them and have stood up well and will go into winter with a good cover.

#### **Membership Director - Paul Warren**

In summarising the past year it is interesting and important for members to understand where our strengths and weaknesses lie. Shepparton Park's ongoing success will be dependent on how we maintain our numbers into the future. The past twelve months have seen a marked variation in our membership base.

Full membership numbers fell by eight while this is a decline from last season there are varying factors. - (2) The minutes must record the business considered at the meeting, any resolution on which a vote is taken and the result of the vote.
- (3) In addition, the minutes of each annual general meeting must include—
  (a) the names of the members attending the meeting; and
  (b) the financial statements submitted to the members in accordance with Section 30 of the Act
  - (c) the certificate signed by two committee members certifying that the financial statements give a true and fair view of the financial position and performance of the Association; and
  - (d) any audited accounts and auditor's report or report of a review accompanying the financial statements that are required under the Act.

#### 33 Custody of inspection of books and records

- (1) Members may on request inspect free of charge-
  - (a) the register of members;
  - (b) the minutes of general meetings;
  - (c) subject to subrule (2), the financial records, books, securities and any other relevant document of the Association, including minutes of Committee meetings.
- (2) The Committee may refuse to permit a member to inspect records of the Association that relate to confidential, personal, employment, commercial or legal matters or where to do so may be prejudicial to the interests of the Association.
- (3) The Committee must on request make copies of these rules available to members and applicants for membership free of charge.
- (4) Subject to subrule (2), a member may make a copy of any of the other records of the Association referred to in this rule and the Association may charge a reasonable fee for provision of a copy of such a record.
- (5) For purposes of this rule—

*relevant documents* means the records and other documents, however compiled, recorded or stored, that relate to the incorporation and management of the Association and includes the following—

(a) its membership records;

- (b) its financial statements;
- (c) its financial records;
- (d) records and documents relating to transactions, dealings, business or property of the Association.
